EMENTA: Concede aumento de vencimentos aos servidores ocupantes de cargos efetivos, comissionados e dá outras providências.

O PREFEITO DO MUNICÍPIO DO SIRINHAÉM-PE, no uso de suas atribuições legais, faço saber que o Plenário aprovou e Eu sanciono a seguinte Lei:

Art. 1º - Fica concedido reajuste de vencimentos aos servidores do quadro de pessoal da Prefeitura de Sirinhaém, percentual 8% (oito por cento) abaixo especificado:

a) Professores do Ensino Infantil e de 1ª a 4ª séries, Ensino Fundamental de 5ª a 8ª séries e Professor H/A (Hora Aula).

b) Servidores ocupantes de Cargo em Comissão;

c) Profissionais de Saúde do PSF, Ativos, Contratados, Inativos e Pensionista.

Art. 2º - O menor vencimento pago aos servidores do Sirinhaém não poderá ser inferior a R\$ 260,00 (Duzentos e sessenta reais).

Art. 3º - Esta Lei entrará em vigor na data de sua publicação, retroagindo os seus efeitos financeiros a partir de 01 de maio de 2004.

Art. 5º - Revogem-se as disposições em contrário.
